On May 13th, 2021 a Request for Proposals was circulated for the following summary of professional services:

• Excavation of ground material, site survey, installation of concrete, gravel fill and drainage system.

Interested firms were invited to submit Bid Form. Subcontractor Form, Tax Payer ID number, Substitution Sheet, and Bidder Eligibly Certification Form.

The bid opening was held Thursday May 27th, 2021 at 1:00 p.m. 2 firms submitted bids. (see the attached Bid Tab sheet).

The low bidder, Irving Construction CO IND., had bid of \$48,490.00. We accepted a change order (substitution) and the project cost is now \$47,490.00. The company had excellent references and the bid was within updated estimates of the architect for the project.

Approval of the bid from Irving Construction CO. IND. is recommended.
