<u>WRITE-IN CANDIDATE</u> Tuesday January 31, 2023	Last day a person may file a notarized Declaration of intent to be a write-in candidate with the proper election authorities (county clerks) by 5:00 p.m. Write-in votes shall only be counted for persons who have filed a declaration of intent. An original Declaration of Intent must be filed with <i>each</i> election authority not later than 61 days before the election.	County Clerks of DeKalb, Boone, Winnebago, Lee, Kane LaSalle, and Ogle
<u>Voter Registration</u> Wednesday January 4, 2023	First day for qualifying registered voters presently within the confines of the United States to apply by mail or in person to the election authority (county clerk) for an absentee ballot.	Voter’s County of Residence
Tuesday March 7, 2023	Last day to register to vote or transfer registration Exception: grace period registrants.	Voter’s County of Residence

<u>Early Voting</u> Monday March 20, 2023	First day for early voting at permanent polling places other than the office of the election authority.	Voter’s County of Residence

<u>Write-In Candidate</u> Monday May 1, 2023	Within 5 days of the proclamation of results, a successful write-in candidate must file a Statement of Candidacy and receipt for filing statement of Economic Interest with the County Clerk.
