## Section 1: How to Use the IRS Data Retrieval Tool

1. Go to [www.fafsa.gov](http://www.fafsa.gov) and click “Login”
2. Enter your FSA ID and Password and click “Next”
3. Create a “Save Key” and click “Next”
4. Click on the “Financial Information” tab \*

Click **Proceed to IRS Site** to continue. Otherwise, click **Skip IRS Transfer**.
