What Federal Benefits Am I Eligible For?

There are several benefits that veterans may be eligible for and which ones you are eligible for will depend primarily on when you served.

REMEMBER: All Veterans Must complete a "Veterans Enrollment Certification Request Form" every semester and GI Chapter 30, 33 & 1606 must also verify their enrollment status on the last day of every month. For complete information, visit www.benefits.va.gov for complete information

1. Montgomery GI Bill - Chapter 30

To receive benefits under this bill, you must have:

- Completed an initial period of active duty and have received an honorable discharge.
- Provide a copy of your Notice of Basic Eligibility (NOBE) Letter.

You are eligible for:

- 36 months of eligibility
- Eligibility of benefits will last for 10 years from your date of discharge.

2. Montgomery GI Bill - Selected Reserves - Chapter 1606

To receive benefits under this bill, you must have:

- Enlisted, reenlisted, or extended an enlistment in the Selected Reserve or National Guard after July 1, 1985 (i.e., no obligation to serve for a period of not less than 6 years.)
- Bring in the Member 4 copy of your DD-214.

You are eligible for:

• 36 months of eligibility

3. Post 9/11 GI Bill- Veterans Education Assistance Chapter 33

To receive benefits under this bill, you must have:

 Served at least 90 days of active duty on or after September 10, 2001.

You are eligible for:

- 36 months of eligibility.
- Eligibility of benefits last 15 years from date of discharge.
- Up to \$1,000/year book stipend (\$41.67/credit hour).
- Monthly Housing Allowance paid to student (must be enrolled more than half-time to qualify).

4. Vocational Rehabilitation & Employment (VRAE) - Chapter 31

To receive benefits under this bill, you must be:

- Entitled to receive compensation for a service connected disability at a rating of 10% or greater for veterans, 20% or more for active duty service members.
- Discharged from active duty under conditions other than dishonorable.
- Pursuing education that leads to employment.

In addition to education & training benefits, you are eligible for:

• Counseling services in the VRAE program located in the Chicago Office.

5. Survivors & Dependents Educational Assistance Program - Chapter 35

To receive benefits under this bill, you must be:

The Spouse or dependent children (ages 18-26) of deceased veterans or 100% disabled veterans eligible. The veteran's
death or injury must be service related.

You are eligible for:

45 months of benefits.

6. Frye Scholarship

To receive this scholarship, you must be:

 Benefit is available to the children and surviving spouses of service members who die in the line of duty after Sept. 10, 2001

Eligible for:

- Entitled to 36 months of benefits at the 100% level.
- Have 15 years to use the benefit.

Getting Started Steps for Veterans

To get started as a Kishwaukee College student is similar for Veterans and non-veterans. As a Veteran, you will have a couple extra steps!

- 1. If you are a new student to Kishwaukee College, apply for admission to KC by completing an enrollment application form or "New Student Information Form." This form can be completed online on the College website or in the Enrollment Services Office (C2100).
- 2. Apply for federal and state benefits through the respective agencies. (Pages 4-7)
- 3. Get started with a counselor to discuss your career goals and register for classes.
- 4. Once registered, check in with the Financial Aid /Veterans Assistance Office to complete your Veterans Enrollment Certification Request form. Remember: you will fill out this form EVERY semester!
- 5. Once all information is turned into the Financial Aid/VeteransAffairs office, certification of your courses can be completed.

You will also need to provide:

A copy of your letter of eligibility from the VA or State of IL.

If you have attended another school and used your benefits, you will need to:

- Complete VA form 22-1995 with Kishwaukee College.
- Provide your official transcripts to the Records Office to be evaluated and a Member 4 copy of your DD-214.
- If you are attending another institution and completing some courses simultaneously, you will need to provide a "Parent Letter" from the other institution.

What State Benefits am I Eligible For?

1. Illinois Veteran Grant (IVG)

To receive benefits under this bill, you must have:

- · Entered the service from the state of Illinois.
- Returned to Illinois within six (6) months after discharge.
- · Served at least one full year of active duty.
- · Received an Honorable discharge.

You are eligible for:

Tuition and some fees to the school.

2. Illinois National Guard Grant (ING)

To receive benefits under this bill, you must have:

• Participated in an Illinois National Guard unit for at least one year.

You are eligible for:

Tuition and some fees to the school.

3. MIA-POW State Grant

To receive benefits under this bill, you must be:

 Dependent of a service person who was a resident of Illinois upon entering the service and whose status is or has been: prisoner of war/missing in action, killed while in the services or died as a result of a service related disability, or is 100% disabled.

You are eligible for:

Tuition and some fees to the school.

If you would like to receive benefits as a student at Kishwaukee College: you must present your letter of eligibility to the Financial Aid/Veterans Assistance Office before your grant can be activated.

^{*}Summer semester sessions are reported according to the dates of enrollment.

NOTE: VA payments may vary based on length of course.

Standards of Academic Progress

Students must maintain academic standards to use their state and federal benefits. KC follows the same standards and academic procedures for ALL students (including students using VA benefits). This is explained on pages 7 and 8 of the Kishwaukee College Financial Aid Handbook. Students with *unsatisfactory academic progress* will be ineligible to use their state and /or federal benefits.

Withdrawing From Classes

If you do not plan to attend the classes you register for, you must officially withdraw from those classes. To withdraw from a class or classes, go to Enrollment Services Office (C2100) and complete a withdrawal form. You must also notify the Financial Aid/Veterans Affairs Office at Kishwaukee College.

*Failure to officially withdraw from a class may result in your receiving benefit pay for classes you are not attending. Overpayment can mean that you will have to repay the VA.

NOTE: *All Withdrawals* from classes must be reported to the VA for students who have the Montgomery GI Bill. If you have to withdraw from classes and you feel you have extenuating circumstance, please stop by the Financial Aid/Veterans Affairs Office. The VA will take this into consideration when they adjust your pay and process your withdrawal. This may prevent you from being in overpayment for your GI Bill.

Called Up to Active Duty

If you are called up for active duty, please contact the Financial Aid/ Veterans Affairs Office at Kishwaukee College before you leave, by calling 815-825-9328 or email finaid@kishwaukeecollege.edu

- We will need a copy of your orders.
- Once verified your classes will be processed as a "drop" (this would not be Withdrawal) and your education benefits pay will stop as of the drop date.
- You will not have to repay any money already received from your GI Bill during the semester.

If you do not follow the above instructions, you may owe money back to the school and/or the Department of Veteran's Affairs.
