Introduction

The pages that follow contain an overview of Kishwaukee College's *Alcohol, Tobacco and Other Drug* [ATOD] policy, as well as all the programs and events on ATOD topics that were produced and/or sponsored by the College during the time period spanning from Fall 2021 through Spring 2023.

The purpose of this document is to provide a record of the College's work in this area, as well as an instrument upon which to build in the future. As per the *Drug Free Schools and Campuses Act*, this document will be kept on file for a period of two years. It will be in the Director of Student Success Office and on the college website.

<u>Distribution of ATOD policies/procedures for students and employees</u>

The Kishwaukee College Alcohol, Tobacco, and Other Drug Policy is included in the College's publication entitled, "Annual Security Report." This publication is produced jointly between the Director Campus of Campus Safety and Security, The DeKalb County Sheriff Department, Vice President Student Services, and the Director of Student Success, on an annual basis. Employees receive notice each year through the College's employee e-mail system when the report is available for viewing on the <u>campus security webpage</u>. Copies are also available in the Director of Student Success office.

ATOD policies/procedures are distributed to students through various means. Many of the policies/procedures are included in college publications such as the College Annual Security Report, Student Online Handbook, Student Athlete Handbook, College Online

Catalog and on the College website and portal. The Annual Security Report is emailed to students and employees each fall.

Description of the ATOD Program Elements

The Alcohol Tobacco and Other Drug program at Kishwaukee College consists of several components. They are as follows:

- Events and activities focused on education and prevention sponsored by departments across campus including Student Involvement, Academic Advising/Student Services, Human Resources, and the College Wellness Committee.
- Curriculum focused on ATOD issues identified across divisions.
- College policies are enforced administratively by the Vice President of Student Services, Director of Student Success, Human Resources, and Campus Security Services staffed by the DeKalb County Sheriff's Office. The College partners with Safe Passage Domestic Violence Agency, Braden Counseling, New Hope Counseling Center, Northwestern Ben Gordon Center, Change Counseling, Sinnissippi Centers and various other outside resources in DeKalb and Ogle County.
- All disciplinary actions taken against students for violations of the code of conduct are administered by the Office of the Director of Student Success.

Prevention/Awareness Events Held Within the Last Two Years

Human Resources Programs:

- 1. Employee Assistance Program available to all staff. Counseling personal issues for staff and household family members is available.
- 2. Fitness Program a flexible membership program which is a contract between the employee and BCBS. This provides access to more than 8,000 fitness centers nationwide. Work out close to home, work or while traveling. You select any gym, there is no direct contract with one facility.
- 3. Voluntary benefits in cooperation with AFLAC accident, cancer specific coverage, critical illness coverage, hospital indemnity, etc.
- 4. Offer voluntary supplemental Life Insurance through Reliance Standard.

Student Services Programming:

- 1. Director of Student Success contributes to the Behavioral Healthcare Committee, approving mental health verbiage and other informational literature associated with the DeKalb County Community Mental Health Board.
- 2. Annual security report emailed to students and employees each October which includes the Biennial Review and links to the Drug Free Schools and Community Act/Illinois Sanctions and Penalties and the National Institute on Drug Abuse.
- 3. Drug Free Schools link on webpage.
- 4. Alcohol and Narcotic Assistance/Substance Abuse and Mental Health Treatment Locator on Kishwaukee's website.
- 5. Sexual Assault/Domestic Violence Awareness programming.
- 6. In Spring 2022, Wellness Wednesday programming was created in collaboration with the Health Services Department and Student Services. This programming features senior nursing students providing peer to peer support services with such information as DUI, mental health and wellness and substance use topics. Since the creation of Wellness Wednesday, the event has taken place twice a semester during the Fall and Spring semesters.
- 7. In spring 2022, Title IX and Preventing Sexual Assault presentation was created and shared in 4 classes to promote confidential advisor services:
 - Students were sent remote activities and assistance offerings focused on Sexual Assault Awareness Month hosted by Safe Passage
 - Women in Blue Jeans Day, build awareness of women and donation provided to Safe Passage.
 - Promotion of Walk a Mile in Their Shoes sponsored by Safe Passage
 - Viewing of Athlete, A for students and staff, sponsored by the Colleges Women Student Union Club.
- 8. In Summer 2022, Talkspace flyers for mental health services were created for classrooms and restroom areas.
- 9. In Fall 2022, handouts were placed in the Student Service Advising lab pertaining to resources for support groups located within the community.
- 10. In Fall 2022, the college created a Mental Health Newsletter with information provided to us from Talkspace. The newsletter also includes information from our local agency partners and one of our partners, Braden Counseling, offers DUI/Substance Use counseling treatment services.
- 11. In Summer 2023, additional substance use and mental health treatment information, www.rehab.com/illinois was provided on the college's Mental Health and Personal Counseling webpage.

Student Activities Programming:

Fall 2022:

- Work out Wednesday virtual exercise activities throughout the semester, promoting stress reduction that leads to unhealthy behaviors.
- Stress Relief Week focuses on activities and information to promote effective stress relief coping skills.
- We Care Pregnancy opportunity on campus for students to promote support services and provide educational materials for expecting mothers.

Spring 2023:

- Work out Wednesday virtual exercise activities throughout the semester, promoting stress reduction that leads to unhealthy behaviors.
- Sexual assault programming for the month of April (Safe Place Selfie Day and NOH8 Campaign Photo Shoot)

Athletics:

The athlete code of conduct coincides with Kishwaukee College's student code of conduct.

The current policy for Alcohol, Tobacco and Drug Use includes:

"The college policy states that each student-athlete refrains from illegal substances at all times. The NJCAA bans the use of alcohol, drugs and all tobacco products during any athletic related event, scrimmage, practice, travel, or games. Failure to comply will be treated on an individual basis and may be grounds for suspension and/or dismissal from the team. Student athletes may be subjected to random drug testing during each semester. Failure to comply with a testing request is considered an admission of use." (Pg. 5, #4)

Fall 2022:

Fall 2023:

 Athlete Orientation Virtual Presentation to three groups of student athletes, which focused on Code of Conduct, Mental Health assistance and the Comprehensive Policy on Sexual Misconduct.
